Now done. Vessel placed in Dry Dock. Keel & Bottom examined, twelve rivets in one keel butt strap renewed and the bottom recoated. Wood Ceiling $2\frac{1}{2}$ " thick fitted on top of floors in holds, half round sparring fitted up sides in holds, and wood sparring 2" thick fitted in tween decks. Sounding pipes fitted to each hold, and additional Ventilators. The steering gear overhauled & the Vessel otherwise put in good and efficient condition.
