CUNARD EXPRESS STEAMER No. 735.-

We are duly in receipt of your letter of yesterdays date returning the duplicate plans relating to the proposed modification affecting the ship's side between the shelter and promenade decks.

We have as requested shewn the position of the various openings in the vessel's side and trust that this will give you the required information. We may say that if the side of the promenade deck space had not been extended as now proposed, the openings in the side between the main and upper decks would have had to be provided for according to the latest Cunard pro-forma plan, and these would, as you will observe, cut through the lower doublings, therefore the present proposed modification will be more advantageous to the vessel if the doublings are lifted clear of the openings between the main and upper decks, *as shown in enclosed sketch.* We shall be pleased to hear from you at your earliest opportunity.

We beg to return you the duplicate plans.
