Outstanding fees

Information has been received that the builders of this vessel, Messrs. Travewerft Ebschner and Gabler, Lübeck, are in serious financial difficulties and a Lübeck court has appointed a temporary administrator to receive claims against the company and to endeavour to arrange for a temporary settlement. At a recent meeting of creditors it was stated that there was no prospect of meeting these claims at present and it was uncertain as to how far they could be met in the future.


The amount due to the Society in fees for survey of hull and machinery of the subject vessel totals DM 6244, made up as follows: -

The account has been rendered to the Builders from the Düsseldorf office but payment has not been made.

I have discussed this matter with Mr. Walburn who suggests that the survey fees might be recovered from the Shipowners, Messrs. Coastal Shipping Co. Ltd., Dublin. The classification Certificates have not yet been received from your office and it is possible that the owners have not completed payment of their final instalment to the Builders

It is therefore proposed, for the Committee's consideration, that the Owners be approached in this matter and that the issue of classification certificates be withheld meantime. The load line certificate has already been issued.
