
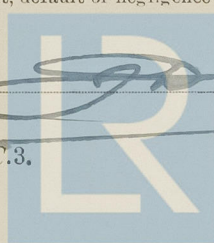
A record of RMC can be made in the Register Book until all fees, travelling expenses, &c., due to the Society are paid.
