This ex Italian vessel was built in 1925 and classed with the Registro Italiano. The vessel has been taken over by the Ministry of War Transport and managed by the City Line who desire the vessel to be classed in Lloyd's Register. The BOMBAY Surveyors were duly instructed regarding the Society's requirements in this respect.

The BOMBAY Surveyors report (9.42) the vessel placed in dry dock, bottom coated and a GENERAL EXAMINATION held, the vessel found in good condition throughout and no major repairs were found necessary.

The shell plating has been drilled as indicated on the Report. Sketch of the arrangement of oil fuel tanks and double bottom tanks are also indicated on the Report, but no structural plans have been forwarded.

There are 225 fathoms of 2-1/8" dia. chain cable on board. The Surveyor recommends that these be brought up to the Rule requirements. This may be at the end of the present emergency.

IT IS SUBMITTED the vessel appears worthy to have a notation of "LOCAL with freeboard, class contemplated" and "Examined 9.42" valid for 12 months and record of docking survey 9.42 assigned.
