REPAIRS, OR EXAMINATION AS PER RULE, FOR Damage, stated to have been caused by collision with the S.S. "ATHENIC" in the River Tees on 13th Feb. 1931, the trawler being at the time moored at Messrs Smith's Dock Co's quay.
Now done: Vessel placed in dry dock, and bottom and rudder examined.

Damage Repairs:

Port side aft: 2 bulwark plates removed, faired & refitted. 1 bulwark plate faired in place. 2 lengths bulwark rail bar and segmental moulding removed, faired & refitted. 1 length bulwark rail bar faired in place. 1 bulwark stay renewed, 3 bulwark stays removed faired & refitted & 1 bulwark stay faired in place. Waterway angle released, part wood deck lifted, and stinger plate faired in place in 3 places. Waterway angle P.T.O.


