When the skin planking, or ceiling are of unusual thickness the breadth of vessel to inside should be reported if possible.
When an allowance for deck erections under Para. 11 where the sheer drops abaft amidships is to be taken from the level of the top of the amidship beam.
When the height of the R.Q.D. is to be taken from the level of the top of the amidship beam.
When the vessels having total standard mean sheer means the sheer measured at the stem and sternpost.
When the vessels having poops and forecastles, it means the sheer measured at points distant from the vessel's length from stem and stern-post.

† State dimensions of freeing port area on back of this form.
‡ The Surveyor should state whether the fall in sheer as reported is measured relatively to the straight line of keel or to the water line. If measured relatively to water line the vessel's draft at time of survey, and also the usual load draft forward and aft should be reported.

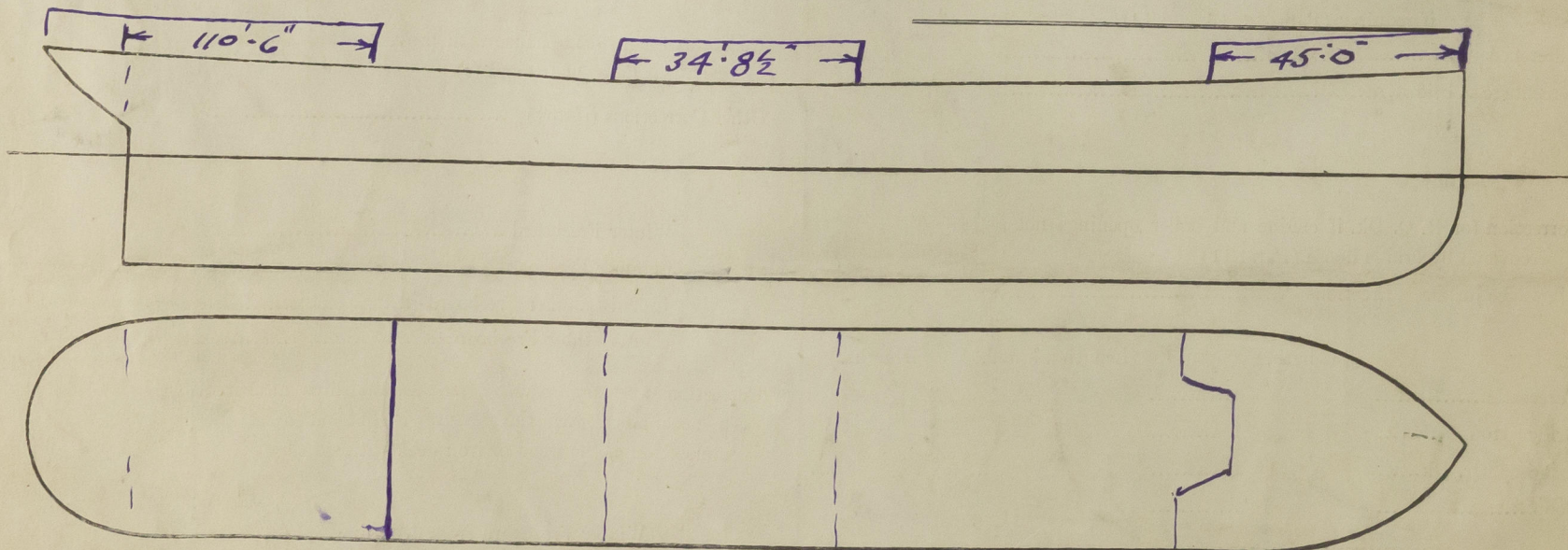

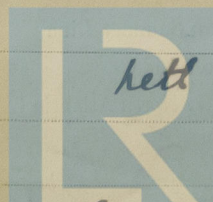
