

Switches, Circuit Breakers and Fuses, are they as per Rule Yes, are the fuses an approved type Yes, are all fuses labelled as per Rule Yes, are the reversed current protection devices connected on the pole opposite to the equaliser connection —, have they been tested under working conditions —. Joint Boxes, Section Boards and Distribution Boards, is the construction and position as per Rule Yes. Cables, are they insulated and protected as per the appropriate Tables of the Rules Yes, if otherwise than as per Rule are they of an approved type —, state maximum fall of pressure between bus bars and any point under maximum load 5.2 Volts, are the ends of all cables having a sectional area of 0.04 square inch and above provided with soldering sockets Yes.
