EXAMINATION AND REPAIRS AS PER RULE FOR Condition. Attended vessel at the request of the Supt. Engineer for the purpose of examining the hull prior to vessel being towed from Barry to the British Iron & Steel Corporation, Briton Ferry, or Newport as a hulk for breaking up, the towing arrangements being the responsibility of the Owners, and the vessel unclassified for duration of voyage.

Now Done:- Weatherdecks, superstructures and casings, hatchways, tank coamings, covers, ventilators, airpipes, skylights, companionways, and all closing and securing appliances examined, tightness of tanks and bilges verified from sounding records, and hull considered in fit condition for the intended voyage.
