A SPECIAL SURVEY (D) became due 11,56 and postponement to 11,57 approved (18.10.56) provided a satisfactory General Examination held.

The NEWCASTLE Surveyors report (12,56), this tanker remained in dry dock, bottom coated and the SPECIAL SURVEY (D) due 11,56 commenced.

On account of wear and tear repairs effected and a number of bottom and side shell plates renewed at this time also internal structure in cargo tanks.

The requirements of a General Examination have been complied with at this time.
