Drillings at ends to be made in the vicinity of the peak bulkheads.

The class is subject to permanent repairs to indented bottom and side shell plates etc. (p & s) at the first convenient opportunity.

The PIRAEUS Surveyor reports (4.48) the vessel placed on slipway and renewals and repairs effected to shell plating, frames, floors etc. on account of damage through grounding, as above.

The requirements of a PERIODICAL SPECIAL SURVEY (D) have been carried out concurrently with the damage repairs and the shell plating has been drilled with satisfactory results as above.

Renewals and repairs effected to shell, deck and tank top plating, bulkheads etc.

The existing cross bunker has now been converted for oil fuel as per approved plan and the requirements of Section 20 of the Rules complied with.
