EXAMINATION AND REPAIRS AS PER RULE FOR A hole was discovered while chipping in Starboard G Strake immediately abaft frame 83 from aft. See Rpt. 10 attached.

Now Done. On 2nd November 1958 a 3/8" thick mild steel doubler 2'6" wide by 4 feet high was fitted with hole in plate at centre and was welded all round. This doubler was hose tested and found sound and tight.
