Re.: Current number 43676 - S/S "EL GAMIL" -

In order to be able to examine the quality of hull risks written by our Agencies abroad, we apply to the classification notes of your Register of Shipping. This was also the case when we received at the time the information of our Alexandria Agency that they had accepted a share of the insurance sum of the above mentioned steamer. Now as you are surely aware the ship has ~~sunk~~ in the month of October of this year. In connection with this total loss we heartily particulars regarding the condition of the ship, which caused to us the suspicion whether the S/S EL GAMIL has obtained with right the highest classification i.e. + 100 A 1 + LMC. We think we are entitled to ask this question because the ship was built in 1904 and it is surely an extraordinary case, that a ship of such an age is classified in the manner like in the present case.

We should be very thankful to you, if you would let us have your prompt reply to this matter and in expecting the same, we remain, Gentlemen,
