Referring to our telephone conversation of yesterday we attach herewith our drawing showing the modifications to the internal structure of the above type vessels which we are carrying out. The modifications were taken from an American drawing originally lent to us by you and follows your recommendations except in the case of the longitudinal bulkhead where we prefer to crop the bulkhead and fit the straight plate rather than the additional brackets shown on your blue print.

We have followed this procedure at Swansea, Cardiff and the Tyne with the concurrence of your local surveyors.
