We acknowledge the receipt of your favour of the 3rd instant with reference to the survey carried out on the above vessel in September last and note a docking date 9.47., examined 9.47., B.S. 9.47 and T.S. (seen) 9.47., has been assigned, whilst thanking you for this information, we note also that No.3 tank requires to be tested before different grades of oil are carried in Nos. 2 and 3, whilst the machinery spare gear and electrical fittings in the centre castle 'tween deck space also requires attention. The latter points will be dealt with on the occasion of the next overhaul, but we shall be obliged if you will advise us as to what machinery parts you have in mind when making your recommendation, also what equipment and anchor cable is required to comply with Rule requirements.

Upon receipt of this information the matter will be given further consideration and dealt with as circumstances permit.


