EXAMINATION AND REPAIRS AS PER RULE FOR Alterations.

Existing generator seating situated at the ~~port forward~~ ^{port forward} end of the Engine Room was removed and a seating for a new "ALLEN" 150 KW diesel generator was built in approximately the same location in accordance with the locally approved plan, copy attached.

Examined internally No. 5 Double Bottom Tank (SS) in way of the seating, but no additional stiffening to the ship's structure considered necessary. Numerous tank top rivets renewed in order to reduce existing 3 ply riveting to 2 ply, and tank top tested upon completion of the work.
