I have surveyed the above ship in accordance with the Rules for CONDITION SURVEY

At the request of the owners, a condition survey was carried out, as far as practicable, while the ship was lying afloat at GRANGEMOUTH, on 3rd May, 1963 and subsequently, for the purpose of issuing a Report 10, to permit the ship to proceed to a Spanish port, under tow, and in ballast condition.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.
Now done: An examination was made of weather decks, superstructure bulkheads with their closing appliances, casings, companionways, coamings, hatchways and their closing appliances, ventilators and deck openings. Windlass and equipment, found or placed in satisfactory condition.

Anchors made ready for easy working. Rudder and tiller firmly fixed in centreline position, side scuttles and deadlights efficiently closed. All doors, locks, etc., found or placed in good condition.

Prior to departure the towing superintendent indicated that he was satisfied with the condition of the ship, for the contemplated voyage.
