The ABERDEEN Surveyors report the vessel placed on slipway, bottom coated, a 2nd SPECIAL SURVEY No.3 carried out including drilling of shell plating with results, as shown above, which when the renewals as recommended have been carried out will be satisfactory.

Due to wear and tear renewals and repairs have been effected to deck, casing and bulwark plates etc.

It is stated the vessel will be dry docked at Hull within 6 months time when the shell plating will be made good.

IT IS SUBMITTED the vessel is worthy to remain as classed with record of docking survey 9.45 and notation of S.S. Abn. No. 3-10.45 subject to renewals and repairs to shell plating at the first opportunity. The notation of S.S. 2nd No. 3 to be assigned when shell plating has been dealt with.
