Drysdale & Co., Ltd., attend at their works at Yoker, Glasgow, W.4., on the 16th December, 1946 and subsequent dates for the purpose of examining and testing One 7" Horizontal divided centrifugal pump intended for cylinder cooling purposes, manufactured by them under Job No. F.6165 to the order of Messrs. R. & W. Hawthorn Leslie & Co., Ltd., and intended for Order No. 4038.

The pump which was driven by a vertical enclosed type steam engine was examined under working conditions and the following results were obtained:-

The steam cylinder and pump casing were tested under hydraulic pressure to 360 and 50-lbs per square inch respectively and found sound and tight.


