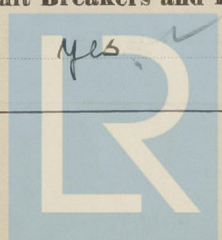

The nearest cables to the compasses are as follows:—

A cable carrying *5* Amperes ☒ feet from standard compass *3* feet from steering compass.

A cable carrying *2.75* Amperes ☒ feet from standard compass *3* feet from steering compass.

A cable carrying *2.5* Amperes ☒ feet from standard compass *to* feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power *yes*

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted *yes*.

The maximum deviation due to electric currents was found to be *nil* degrees on *—* course in the case of the standard compass, and *nil* degrees on *any* course in the case of the steering compass.
