This is to Certify that this Ship has been surveyed by the Surveyors to this Society, and was reported to be, on the *3rd July, 1947* at *Cardiff* & in *November 1948* at *Glasgow* in a fit and efficient condition as is prescribed by the Society's Rules for the safe carriage of dry and perishable or other approved Cargoes, and has been CLASSED and entered in the REGISTER BOOK of this Society, with the Character **100A1** *Specially Surveyed Cardiff - 7.47* with freeboard

subject to Periodical Surveys as required by the Rules, & to indented shell plating etc (s.s.), shell plate F8 (p.s.) & fire damage to deep tank bulkhead & deck (p.s.) being dealt with at the first convenient opportunity, to buckled plating & stiffening of bulkhead between Nos. 1 & 2 holds being dealt with at the first opportunity & to 45 fathoms of chain cable being supplied at the end of the present emergency.
