1. Heavy weather on the 16th September 1930 on a voyage from Tönsberg to Montevideo.
  2. Touching the whaler "ROSS" on the 20th September 1930 at Montevideo.
  3. Heavy weather on the 30th September 1930.
  4. Going in ice on the 2nd, 5th and 31st October and 6th, 7th and 11th November 1930.
  5. Ice in propeller on the 22nd October 1930.
  6. Heavy weather on the 14th January 1931.
  7. Touching the whaler "ROSS" on the 26th March 1932.
  8. Piece of whale damaging the port winch on the aft flensing plan.
  9. Heavy weather on the 7th April 1931 on a voyage from Admiralty Bay to Tönsberg.
  10. Grounding on the 17th January and 14th February 1933 at Harburg.


