Nature of Survey _____

This ship was built by Messrs. Cantieri Navali Riuniti, Palermo.

Rule dimensions:- 430.27' x 56.76' x 33.29' (35 as lkt)

Scantling Nos. 14324 and 38748

Proportions Length = 12.9 depths

The plans of this ship were examined in this Office in 1930 and the scantlings and arrangements as shown and amended approved for the class 100A1 Carrying Petroleum in bulk, with the special notations "Longitudinal Framing" and "Bracketless System".

The ship, however, was not constructed under Special Survey. (See correspondence)

The case received consideration in September and October the ship being then complete and awaiting trials of last year, when classification with this Society was again desired, and the Genoa Surveyors were informed that the Committee would be prepared to class the ship provided a satisfactory report on a survey held by them was received, (Dr. Webster of the Glasgow Office to join in the survey) and the requirements of the Rules for a ship not built under survey complied with the Surveyors' report has now been received, from which

appears that the ship has been constructed generally in accordance with approved plans and the Society's Rules.

Some additional reinforcements have been fitted to the ship to the satisfaction of the Surveyors.

The Surveyors submit the Owners' requirements are recorded as 11,34 for favourable consideration.
