

| "C" strake, plate No. 6 set up                              | To be renewed.   |
| 15 side shell frames buckled                                | To be cropped, part removed, faired and replaced.  |
| 29 Floors buckled   | To be cropped and part renewed.  |
| 41 bottom frames buckled                                    | To be cropped and part renewed.  |
| 208 bottom longitudinals buckled                            | To be renewed.   |
| Centre girder buckled                                       | To be cropped and part renewed.  |
| 8 tank side brackets buckled                                | 7 to be faired in place and one to be cropped, part removed, faired and replaced.                      |
| Lower part of rudder plate buckled and rudder arm fractured | Plate to be cropped, part removed, faired and replaced, and fracture in arm to be veed out and welded. |

Removals to be made as necessary in order to carry out the above recommended repairs and afterwards replaced with part new material as required.

On completion all repaired and disturbed work to be tested, proven tight and afterwards coated.

These recommendations were made in order to restore the vessel, as far as practicable, to the same condition as before the alleged casualty occurred and have now been carried out to my satisfaction.
