A tonnage opening has been fitted, but the scantlings are suitable for an increase in draught of about 30" in the event of the tonnage opening being closed.

The inner bottom plating has been increased in thickness under the hatchways in lieu of ceiling.

This vessel appears to have been built in accordance with the Rules and the approved plans, and it is submitted she is eligible to be classed LOCAL "with freeboard" "Carrying vegetable oil in midship deep tank" "Fitted for oil fuel 7.47, FP above 150°F"

The Summer Freeboard as shown on the attached extract from the Freeboard Verification Form, now marked on the vessel's sides, to be inserted in the classification certificate and recorded in the Register Book, and further, the remaining freeboards, as shown on the accompanying extract, to be inserted in the certificate of classification.
