I have surveyed the above ship in accordance with the Rules for Wear &amp; Tear Repairs

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

As requested attend on board

Now done for W &amp; T Repairs

The Portside hand brake of the windlass in way of the flat steel bar link supports badly distorted with link pin bent and fractured, now steel supports and pin renewed & all placed in satisfactory condition.

Stead trouble experienced through hold bilge & suctions becoming obstructed.

Ship carried cattle on the hoof.

Found the perforated plates at present fitted over the bilge suctions were becoming obstructed due to animal fodder.

Now done:- In the affected Holds Nos. 3, 4 & 5 Port & Starboard bilge suctions, now fitted with filters; fabricated from perforated plate and constructed angle shaped so as to prevent caking of fodder residues, these were tested on completion and found satisfactory.
