This is to Certify that A.C. van Bezuije, the Under-
signed Surveyor did attend on board the
ms. " N A S S A U "

8656 in Record 1952 whilst the ship was lying afloat and placed in
drydock on the 19th November 1952 and subsequently for the annual
survey and have to report as follows:

Vessel placed in drydock, bottom and rudders cleaned. Both rudders
removed, found in good condition, bushes renewed. Bottom plating
found indented over 6 frame spaces forward of aft. bulkhead hatch
No.2, internal structure in way examined and found good. It may be
agreed to effect repairs to the shellplating by next drydocking as
was requested by the Owners' Superintendent.

Coamings, covers, tarpaulins, supports and securing arrangement of
hatchways, ventilators, airpipes and their closings, superstructures,
doors and fastenings engine skylight, side scuttles, scuppers, guard,
rails and freeing ports, examined and found or made in order.
Poop side plating Port & Starb. in way of crew quarters found badly
corroded just above deck. Plating in way doubled.
Steering arrangement, anchors and windlass examined and found good.

Propellers and outside fastenings of seaconnections examined and
found good. Weardown tailshafts Port : 1 mm. Starb.: 0.5 mm.

Port and Starboard main engines cylinders covers removed and replaced
by new cylinder covers.
Port main engine pistons drawn, cylinders, pistons, crankpins and
brasses examined and found good. New gudgeon pins, made of tested
material, fitted, gudgeon pinbushes bored out.


