We acknowledge your letter of 16th April, asking our intentions regarding the Special Survey of the above steamer. This vessel has just arrived in the United Kingdom, and completes discharge of her cargo in Boulogne about 3rd May.

We are now offering the vessel for sale for scrap and although it is not at this stage known to whom she will be sold, it is possible she may be sold for delivery in the Far East, in which case we would look for a suitable charter to work her out to that area. On completion of her discharge, we propose to do the Annual Freeboard Survey. Her movements after completion of discharge will be governed by any charter that may be picked up, but assuming the charter is not in the U.K. or Western European ports, we would have to bring her to a convenient U.K. port for essential repairs and manning purposes. Although no final decision has been made, this could well be Tilbury.

Having carried out the Annual Freeboard Survey, we would not propose to do anything further with regard to this Special Survey.

We will advise you when it is known at which port the Annual Freeboard Survey will be done.

Additionally, we may find a buyer desiring delivery in a U.K. or Western European port, and wanting to make a loaded voyage to the Far East, the vessel to be scrapped there. We would consider three months from the time of sale a reasonable time for the vessel to reach the breakers and would like to know your requirements with regard to the vessel's class under these conditions.
