In reply to your Classing letter dated 23rd Jan. last with reference to our Rpt. 8 No. 23839, we have to say that the Owners have been advised of the Class qualification indicated in the first paragraph of your letter.

In reply to the second paragraph of your letter, we have to say that the Owners are aware of the fact that the drilling survey of the deck and shell remains to be dealt with, as had been previously arranged by the Surveyor with the Owners.

It will be noted that this tanker was under survey over a period of some 20 months, during the latter period of which the surveyor has been engaged exclusively on new construction, and returned only briefly to complete the "Liverpool" partial Special Survey.- The error made in the Report heading and "items to complete" are therefore due to the long interruption in the survey whilst being engaged on new construction, and is regretted.

The Surveyor concerned is at present on temporary duty at Palermo for a period of about 3 months, and a copy of this letter together with your Classing letter have been forwarded to that Port for his information.


