I have surveyed the above-named ship in accordance with the Rules for Re-classification and alterations.

This boom defence vessel was purchased by Messrs. Risdon Beazley from the Admiralty with a view to re-conditioning and conversion to a salvage vessel.

A preliminary Survey was carried out on slipway, with the object of establishing the basis for obtaining quotations for the work involved, shell and deck plating drilled, all tanks and spaces examined internally and found generally to be in good condition with the exception of minor defects in the starboard bunker.

Damage repairs were recommended to soft-nosed stem plating, and to side plating p. & s.

Two deck plates P. & s. were recommended to be renewed on account of pitting, and several plates to be cropped and local inserts fitted.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. I recommend, therefore, that this ship remain as classed with/without fresh record of dry docking

The ship was then laid up on a mud berth at Northam, Southampton, and despite repeated enquiries, no further information was forthcoming, except that the Owners found the beam to be insufficient for the intended purpose.

In March, 1966 the ship was disposed of to a shipbreaker at Antwerp, to which port she was towed.
