REPORT ON LIFEBOATS

This is to Certify that

J. G. Buchanan

the undersigned Surveyor to this Society did at the request of the Owner's Representative attend on board the Steamer "DAULTON MANN" 7176 tons of Bombay on 17th March, 1947, for the purpose of examining the four (4) metallic lifeboats.

The lifeboats are made of steel, are fitted with bar keel and steel gunwales, hoist shackles and have air tanks secured under the side seating. One of the lifeboats is a motor boat. The boats were examined at this time and found in good order.

Each boat has a name plate attached to its bow with its serial number, dimensions, cub. capacity and the initials of the U. S. Steamboat Inspector as follows:
