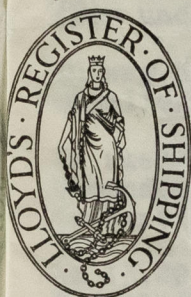

## ON-SURVEY

The On-Survey was carried out in conjunction with Captain Sven Linde of the Charterer Messrs. Redriaktiebolaget Nordstjeruan, Johnson Line, Stockholm.

The following defects were found upon inspection:-

All insulated hatchway plugs found worn but in useable condition.

No permanent gratings are fitted over tweendecks and tank tops in way of insulated spaces except in the lockers.

Wooden floor ceiling in way of No.2 and 4 lower hold patched over at 2 and 14 places respectively.

Lower part of panelling of after bulkhead of No.2 upper tween deck space fitted over with wooden top panelling.

Cement floor cover in way of No.3 bridgedeck (ss aft) broken at several places.

2 shoes of guard rail at No.3 upper tween deck hatchway found loose during the survey. (Now under repair).

Oil leakage at 6th and 7th bilge bracket from fwd. bulkhead of lower hold No.3 (ss) and a smell of diesel oil was noticed during the Survey. (Now under repair).

2 shoes of guard rail at No.5 main tweendeck hatchway missing.  
(Now under repair)

In way of No.6 hold and tweendecks a strong smell of linseed  
expellers was noticed during the survey.

In respect of the smells in No.3 lower hold and No.6 hold and  
tweendecks Mr. S. Linde requested the attending Chief Mate  
to ventilate these spaces adequately).

At 13.00 p.m. on the 29th May, 1963, the quantity of marine  
diesel oil on board was ascertained in conjunction with the  
Chief Engineer to:

Marine Diesel Oil:- 1202.4 long tons

Also the daily consumption of marine diesel oil during  
stay in port was ascertained and found to be 3.0 long tons  
per 24 hours.
