This will acknowledge yours of 5th June 1957, respecting the above vessel, and I regret the delay in writing, but it has been occasioned by my endeavour to contact the Owners, and endeavour which has up to the present not met with success.

I have now written on the matter, to Liberia and await their reply, sending at the same time a copy to the Tenerife Agents.

I wrote and called on the slipway, where the vessel was surveyed in Tenerife, in the hope that they could be of assistance with tailshaft drawings, but the new tailshaft was sized off the old one, and no drawings were made. Since then an outline sketch has been sent me by the yard foreman, but it is quite unsatisfactory for the purposes of the Society.

I regret the unsatisfactory position with this vessel, and feel considerably the advantage taken by the Owners of the ready assistance the Society gave them at time of reclassing, in not meeting their obligations.

As soon as I have any information I shall write, but meantime I feel it is 'coast laziness' and not that the vessel does not conform to the Rules, that is the cause of the Owners neglect.
