S.S. "LUCAS TRADER" 5343 tons gross of Hong Kong as she lay in
dock and afloat at Kasado on the 21st January, 1957 and subse-
quently in order to ascertain the nature and extent of damage stated
have been sustained by (a) grounding in Hsinkang Channel on 31st
January, 1956 whilst on loaded passage Hsinkang to Negata, Japan,
by (b) subsequent refloating operations.

For further particulars please see Log Book.

(a) Upon examination of ship in drydock no damage was
found consistent with the alleged grounding.

(b) Damage however was found consistent with refloating
operations and recommendations made as follows:-

Found.

Windlass gypsy shaft
not running smoothly and
chain cable jamming.

One length (15 fms.) chain
cable fractured at several
links.

After repairs - cable was
examined before testing and
found in order but cable
broke under test required by
Rules and rejected.

Recommended.

Windlass to be opened up and
shaft removed ashore and alignment
of same checked. If found want to
be faired as necessary before re-
fitting.
Windlass to be tried on completion.

Cable to be sent to chain cable
makers at Himeji for repair and
afterwards proof testing.

One length of chain cable to be
renewed and to be supplied with
Lloyd's Certificate.

The above recommendations have been made with the view of restoring the ship to the same efficient condition as prevailed before the stated casualties.

Permanent repairs have now been satisfactorily effected by the Dockyard Co., Ltd., Kasado at a total cost of ¥839,000.- as follows:-

a) Grounding - proportion of drydocking fee	=	¥239,000.-
b) Refloating operations - repairs	=	¥600,000.-
Grand Total:		<u>¥839,000.-</u>

The above are considered reasonable for prevailing prices in Japan.

"Submitted without prejudice"

The ship was painted at this time with one coat of anti-rust and one coat anti-fouling paint from keel to light load line. Also draft marks repainted at a total cost of ¥520,000.- This item is noted entirely without prejudice.
