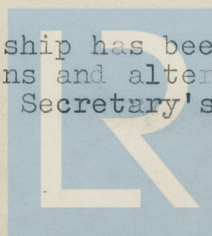
There are no conditions of class.

The HAMBURG Surveyors report (10,56), this ship examined in dry dock, bottom coated and the requirements of a SPECIAL SURVEY (D) now complied with.

On account of wear and tear considerable renewal of bottom and side shell plating and repairs to structure in cargo wing tanks effected.

At this time this ship has been converted to a dry cargo ship, all structural additions and alterations being in accordance with approved plans and Secretary's letter.

The main structural alteration consists of the removal of 4 transverse bulkheads in centre tanks and the construction of additional W.T. bulkheads in wing tanks which increases the number of wing tanks to 8 each side. These wing tanks are now used exclusively for the carriage of water ballast, dry cargo being carried in the original centre tanks. 4 hatchways have been cut in the upper deck and stringer plate and sheerstrake adequately compensated. A tank top has been constructed in way of the centre tanks, the D.B. tanks thus formed being dry spaces.

The thicknesses of shell plating as ascertained by drilling are as stated above and are considered satisfactory.

The thicknesses of deck plating as ascertained by drilling and now reported by the Surveyors are also considered satisfactory.

IT IS SUBMITTED this ship is <sup>Ore Carrier</sup> eligible to have her class amended to #100A1 and to have record of docking 9,56 and Notation of 'ss.Ham. 10,56(Dr)' assigned.
