Vessels obtaining an allowance for deck erections under Para. 11, ships the height of the R.Q.D. is to be taken from the level of the flush-decked vessels the total standard mean sheer means the sheer measured at the stem and sternpost. In vessels having poops and forecastles, it means the one-eighth of the vessel's length from stem and sternpost.
