I have surveyed the above ship in accordance with the Rules for installation of additional butterworth openings in the vessel's main deck plating on August 27 and 30, 1965 whilst the vessel lay afloat at Port Neches, Texas and subsequently on October 26, 1965 at Galveston, Texas.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

Additional butterworth openings installed in the weather deck plating in the following locations:-

No. 1 Centre Cargo Tank - One opening in 4th strake of deck plating inboard of starboard side stringer plate about mid-length of tank.No. 2 Centre Cargo Tank - One opening in 4th strake of deck plating inboard of port side stringer plate about mid-length of tank.No. 2 Port Wing Tank - One opening in 2nd strake of deck plating inboard of port side stringer plate about mid-length of tank.No. 2 Starboard Wing Tank - One opening in 1st strake of deck plating inboard of starboard side stringer plate at about mid-length of tank.No. 5 Starboard Wing Tank - One opening in deck stringer plate at after end of tank.I recommend that this ship remain as classed ~~with~~/without fresh record of ~~dry docking~~ survey, (P.T.O.)

No. 5 Port Wing Tank - One opening in deck stringer plate at after end of tank.

No. 6 Centre Tank - One opening in 4th strake inboard of port side stringer plate at about mid-length of tank.

No. 7 Centre Tank - One opening in 3rd strake of deck plating inboard from starboard side stringer plate.  
One opening in 3rd strake of deck plating inboard of stringer plate port side at about mid-length of tank.

No. 8 Centre Tank - One opening in 5th strake of deck plating inboard from port side stringer plate at about mid-length of tank.

No. 9 Centre Tank  
One opening in 1st strake inboard port side ) Trunk  
One opening in 2nd strake inboard starboard side) deck

No. 10 Centre Tank (Trunk Deck)  
One opening 2nd strake from port side at after end of tank.  
One opening in 3rd strake from outboard port side at after end of tank.  
One opening in 4th strake from outboard port side at about mid-length of tank.  
One opening in 1st strake inboard starboard side at about mid-length of tank.

All openings 12 inch diameter and re-inforcing rings size 18" outside diameter by 7/8 inch thick installed in way of all openings.
