I have surveyed the above-named ship in accordance with the Rules for Damage as result of grounding.

For follow particulars please see separate preliminary damage report No. DAC-114, copy attached.

It was reported vessel grounded at entrance to Masbate Harbor on 3rd October 1965 and vessel was refloated with use of main engines on 7th October 1965.

Diver reported fracture of bottom plate at Stbd. side some 4 ft. from bilge. Keel in way of No. 2 DB (fuel oil) tank, some 5 inches long.

Leakage was also reported at the No. 6 DB (fuel oil) tank.

It was recommended in the circumstances to drydock the vessel in loaded condition for full examination of bottom and underwater parts (1 week); at Mariveles, Bataan, prior to departure of vessel from the Philippines for her voyage to U.S.A.

Vessel is at present loaded at about two-thirds deadweight capacities with cargo (copra) evenly distributed.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. I recommend, therefore, that this ship remain as classed with/without fresh record of drydocking survey, subject to dry docking at Mariveles, Bataan, (1 week), for full examination of bottom and underwater parts as result of grounding and to effect necessary temporary repairs prior to departure from the Philippines for voyage to U.S.A.
