The nearest cables to the compasses are as follows:—

A cable carrying 1 Ampères inside ~~feet from~~ standard compass 6' feet from steering compass.

A cable carrying 25 Ampères 6' feet from standard compass inside feet from steering compass.

A cable carrying Ampères feet from standard compass feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power Yes
