I have surveyed the above-named ship in accordance with the Rules for REPAIRS.

At the request of the Master examined the No.2/3 hold and tween deck bulkhead in way of No.2 access trunkway. Found the bulkhead plating generally wasted in way of the trunk and holed locally at tween deck level and on first plate seam above. As a temporary repair, No.3 hold being insulated, cement boxes have been fitted at these two points examined on completion and found satisfactory. The access trunk door on the superstructure deck has been re-rubbered and toggles overhauled. It is recommended that the bulkhead plating be specially examined and dealt with as found necessary by the end of December, 1966. It was stated that the ship will be drydocked in Japan in that month.

I declare that the items detailed in this report (except as stated otherwise) comply with the requirements of the Merchant Shipping (Cargo Ship Construction and Survey) Rules 1965, applicable to this ship, and are in all respects satisfactory for the service on which the ship is intended to ply namely International voyages/voyages within the limits

(The above declaration applies only to sea-going cargo ships of 500 tons gross and above registered in the U.K.)

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

I recommend, therefore, that this ship remain as classed ~~as~~ without fresh record of dry docking, subject to the No.2/3 hold and tween deck bulkhead in way of No.2 access trunkway being specially examined and dealt with as found necessary by December 1966 and to any other outstanding conditions of class being dealt with as previously recommended.
