I have surveyed the above-named ship in accordance with the Rules for G.E. for postponement of SS "C" due 5/65, Repairs, Load Line and Damage which was alleged to have been sustained when M.V. "GLENEARN" made contact with this vessel whilst anchored at Singapore on the 7th May 1966.

GENERAL EXAMINATION.

Carried out in accordance with requirements and all found or placed in satisfactory condition. A Load Line certificate for the voyage to Amsterdam valid until 31st July 1966 has been issued. It is submitted that the Owners request for postponement of SS "C" due 5/65 may meet the favourable consideration of the Committee.

REPAIRS.

A.P. &amp; F.P. spaces access hatches wasted, part doubled.

Chain locker drainage pump unoperative - now renewed.

Ventilators, aft. accommodation (P & S) wasted, part cropped and renewed  
No.2.D.B. (SS) air pipe wasted part cropped and renewed.

P.T.O.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. I recommend, therefore, that this ship remain as classed ~~with~~ without fresh record of dry docking subject to shell plating F.P. space frame 4 (psf) (cement box) being specially examined and dealt with next dry docking, on to any other outstanding condition of class being dealt with as previously recommended.

## REPAIRS (cont.)

Ventilator cowl (PS) No.2 Hatch wasted to perforation, now renewed.

G.S. pump stool wasted to perforation, now renewed.

Chain cable spurling pipes (P & S) 50% wasted to perforation, part cropped and renewed.

Minor repairs to closing arrangements on mast houses and accommodation accesses.

## DAMAGE.

- 1) Focle bulwark set over and buckled, soft nose stem plating and structures torn loose.
- 2) Sheerstrake plating adjoining main deck at bow structure heavily set in, rivets sprung and main deck plating in way buckled.
- 3) Focle fairlead (SS) fractured, support stool and structures buckled.

## NOW DONE FOR DAMAGE.

- 1) Approx. 10 feet focle bulwark plating and 5 ft. x 5 ft. soft nose stem plating cropped and renewed. Bow breasthook cropped and renewed.
- 2) Sheerstrake plating faired and approx. 5 ft. x 10 ft. main deck plating cropped and renewed.
- 3) Focle fairlead (SS) temporary repair effected.  
Other minor repairs to focle bulwark structures.

## Fore Peak Store.

Shell plating frame 4 (psf) holed, existing cement box broken away new cement box fitted.

## S.R.L. To raise.

Shell plating F.P. space frame 4 (psf) holed cement box fitted to be specially examined and dealt with next drydocking.

- 2) Upper deck plating 1st inboard from stringer abreast No.4 Hatch (P & S) to be renewed adjacent plating to be specially examined.
- 3) Temp. manila rope and wood blocks of aux. steering gear to be replaced by S.W.R. and block.
- 4) Set up shell plating (P & S) with structures in way and bulkhead and D.B. floors, to be specially examined and dealt with by completion of SS.

Items 2 & 3 now examined and considered efficient, subject to being dealt with as previously recommended.

Items ( 1 & 4 ) nothing done regarding these items.

S.R.L. To raise.

Chief Officer reported ingress of oil into No.4S hold bilge.

It was not practicable to investigate the cause of this defect as the vessel was fully loaded.

It is therefore recommended that this be examined and dealt with next drydocking 8/66.

LL.S.T. valid until 31st July issued as authorised.

Existing LL.S.T. issued at Hong Kong, 22nd March 1966 withdrawn.
