PARTICULARS OF DEFECTS, REPAIRS, ALTERATIONS, ETC.

Desuperheater coil in centre boiler stated repaired in one section at Bombay. Complete desuperheater coil removed and renewed this time. Tested to 400 p.s.i.

Forward forced draft fan engine - casting for the guide, cover and hinge fittings for the two eccentric fulcrum pins all in one piece. One lug for the after eccentric fulcrum pin found broken. The whole casting renewed this time with fabricated welded steel and fan engine sighted in operation on completion of repairs.

INTERIM CERTIFICATES ISSUED AT KARACHI DATED 5th May, 1965 and 23rd APRIL, 1965.

From the above certificates on board the vessel, it is noted that records of MBS. 3-65,TS(CL)4-65, ES(with date) when the survey has been completed and a fresh record of drydocking 4-65, have been recommended. In addition, a General Examination for postponement of the Special Survey until May, 1966 is recommended in the above certificates.
