
We state the present position of the s.s. "BLUE MARLIN" for purposes of clarification and record. This vessel should by now have been in Japan but, as you know, suffered a boiler failure enroute Philippine Islands to Australia.

The boiler was inspected by your surveyor at Brisbane and although certificates are not yet to hand, it was agreed that the vessel could proceed to Japan on one boiler and that the boiler which we have acquired in U.S. would be installed there.

It is our intention to commence Special Survey concurrently with boiler installation and we shall be pleased to have your confirmation that this is in order with your goodselves.
