This is to certify that I have surveyed part of the machinery of the S.S. "APJ AMBAR," 5449 gross tons of Calcutta for advancement of MBS, for damage to Inboard & Outboard Generator Engines and for condition of class to Main Condenser Circulating Water Pump while the vessel lay afloat at Cochin on the 23rd January, 1966 and subsequently. and that all my recommendations have been carried out to my satisfaction. I am reporting accordingly and recommending to the Committee of Lloyd's Register of Shipping that the machinery classification should be retained and the following survey records assigned "MBS (with date) upon completion," to condition of class on Main Condenser Circulating Water Pump (certificate of the 17th January, 1966 issued at Mormugoa) being deleted and to all conditions of class being dealt with as previously recommended.

Parts now examined :—

For MBS: Centre Boiler in its entirety and the Safety Valves of Centre and Port Boilers adjusted under steam.

For Damage Repairs: Inboard & Outboard Generator Engines.

For Condition of Class: Main Condenser Circulating Water Pump.

To complete the boiler survey the Starboard Boiler remains to be examined in its entirety, its safety valves to be adjusted under steam and the oil burning system and remote controls to be examined and tested.
