3. The statement in the Rpt. "O.F. can be carried in the nos. 1, 2, 3, 5, 6 and side Bunkers" is in error, as it would appear from the plans that this should read "O.F. can be carried in the nos. 1, 2, 3, 4, 6 P.B's and side Bunkers" but confirmation is desired.
