

Switches, Circuit Breakers and Fuses, are they as per Rule YES, are the fuses an approved type YES, (See Secty's Letter E 22-2-43) are all fuses labelled as per Rule YES, are the reversed current protection devices connected on the pole opposite to the equaliser connection ✓, have they been tested under working conditions YES. Joint Boxes, Section Boards and Distribution Boards, is the construction and position as per Rule YES.

Cables, are they insulated and protected as per the appropriate Tables of the Rules YES, if otherwise than as per Rule, are they of an approved type ✓ state maximum fall of pressure between bus bars and any point under maximum load 6.5 VOLTS, are the ends of all cables having a sectional area of 0.04 square inch and above provided with soldering sockets YES. Are paper insulated and varnished cambric insulated cables sealed at the exposed ends ✓ with insulating compound ✓ or waterproof insulating tape ✓. Are all the cable runs in accessible positions, not exposed to drip or accumulation of water or oil, high temperatures or risk of mechanical damage YES, are cables laid under machines or floorplates YES, if so, are they adequately protected YES. Are cables in machinery spaces, galleys, laundries, etc., lead covered YES or run in conduit NO. State how the cables are supported and protected SECURED BY CLIPS TO PERFORATED TRAYS, WITH SHEET METAL COVERS IN POSITIONS WHERE EXPOSED TO POSSIBLE DAMAGE.

Are all lead sheaths, armouring and conduits effectually bonded and earthed YES. Refrigerated chambers, are the cables and fittings as per Rule YES. Are all cables passing through decks and watertight bulkheads provided with deck tubes or watertight glands YES, where unarmoured cables pass through beams, etc., are the holes effectually bushed YES and with what material LEAD. COMPASSES.

Minimum distance between ^{12 1/2" FAN} electric generators or motors and standard compass 25 FEET.

Minimum distance between electric ^{12 1/2" FAN} generators or motors and steering compass 20 FEET.

The nearest cables to the compasses are as follows:—

A cable carrying .09 Amperes LED INTO feet from standard compass LED INTO feet from steering compass.

A cable carrying .36 Amperes 4 feet from standard compass 3 feet from steering compass.

A cable carrying .15 Amperes 9 feet from standard compass 5 feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power YES.

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted YES.

The maximum deviation due to electric currents was found to be NIL degrees on ANY course in the case of the

standard compass, and NIL degrees on ANY course in the case of the steering compass.
