I have surveyed the above-named ship in accordance with the Rules for GENERAL EXAMINATION FOR MAINTENANCE OF CLASS until 31st October, 1966., LOAD LINE AND SAFETY EQUIPMENT SURVEYS.

In view of the Condition of the parts now examined the Owners request for maintenance of class may, in my opinion, be favourably considered.

S.R.L.No.253:- The cement boxes fitted in way of the wasted T.D. bulkheads and in way of shell plate C.14 in No.5 hold, and No.4 U.T.D. chocks specially examined and considered efficient for the above period.

The vessel has now been sold to Messrs. Embajada Compania Naviera S.A. of Panama, renamed 'CONSULATE' and registered at Piraeus.

I declare that the items detailed in this report (except as stated otherwise) comply with the requirements of the Merchant Shipping (Cargo Ship Construction and Survey) Rules 1965, applicable to this ship, and are in all respects satisfactory for the service on which the ship is intended to ply namely International voyages/voyages within the limits

(The above declaration applies only to sea-going cargo ships of 500 tons gross and above registered in the U.K.)

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. I recommend, therefore, that this ship remain as classed ~~XXX~~ without fresh record of dry docking. Subject as previously recommended, to indented shell plate J.1 (p.s.f.) and internals in way, to wasted bulkheads 1/2 and 2/3 in way of upper 'tween deck to No.4 U.T.D. chocks, to shell plate C.14 (p.s.) in way No.5 lower hold (doubled) being specially examined and dealt with as necessary at next Special Survey, and to the stem and stem plating being specially examined and dealt with as necessary at next drydocking.

(Where conditions of class are recommended to be retained, imposed, amended or deleted, particulars must be stated above and on the interim certificate.)

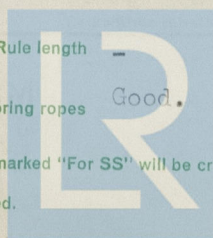

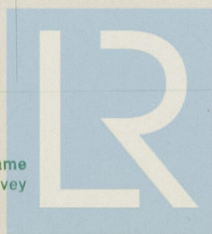
