EXAMINATION AND REPAIRS AS PER RULE FOR Explosion, Fire and Subsequent Sinking.

At the request of the Owner's through their agents Gray Mackenzie & Co., Ltd., proceeded to Bahrain on the 19th February, 1958 for the purpose of issuing an interim Certificate after fire damage in No.5 hold.

On arrival the information given by Lloyd's Agent was that the hatch was battened down and smothering steam was on, but that the following morning on inspection of No.5 hold would be made by which time the fire was expected to be out.

At 2135 hours on the 19th February a violent explosion in No.5 hold wrecked the after end of the vessel followed by fire. As a result of the explosion the Tug "SCHAIL" sank alongside.

The following day an inspection of the vessel was made as far as possible, the aft end up to the accommodation was under water, and the Engine room flooded. The midship accommodation was found to be completely gutted, but Nos. 1, 2 and 2a holds on the fore deck appeared to be tight at this time. The draught ford was 11' 6".

For the next three days tons of wreckage was removed from the fore deck to allow derricks to be rigged to lift pumps etc. aboard.

Deck steam lines were examined and blanks made with the intention of operating the winches by compressed air. All entrances and vents leading into No.1

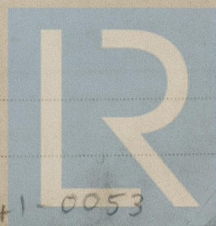
