WEATHER ENCOUNTERED ON PASSAGE FROM BOSTON ON THE 10TH
DECEMBER, 1958 TO 4TH JANUARY, 1959.

It is stated that heavy weather was encountered causing the
vessel to pitch and roll heavily and take heavy seas over the
period. Speed was reduced to lessen the damage to the hull and
machinery the latter being strained heavily. The vessel's
course was altered on the 20th December and put in at Ponte
Nea on the 22nd where the Classification and Lloyd's Agent
Surveyors were called. The vessel sailed the 24th December
and again encountered heavy weather on the 1st January, 1959
heavy seas struck the vessel and caused violent vibrations.
The vessel arrived in Boston on the 4th January, 1959.
