EXAMINATION AND REPAIRS AS PER RULE FOR DAMAGE AND DOCKING

Damage - stated to have been caused by contacts with the quaywall at entrance to the Imperial Dock, Leith, on the 14th March, 1960. Ship on voyage Methil to Leith in ballast condition.

The damage is confined to shell plating and internals in way of No.2 Hold (P&S.F.)

On examination found :-

Shell plate F.4 (P.S.F.) indented between frames at fore end and three shell frames in way slightly set in.
Shell plate F.4 (S.S.F.) indented between frames at mid-length also three shell frames and a short length of bulkhead boundary bar and bulkhead plate in way slightly buckled.

Temporary repairs now carried out :- Shell plate F.4 (P.S.F.) :- 6 frame rivets caulked and afterwards ring welded.
Shell plate F.4 (S.S.F.) :-15 frame rivets caulked and afterward ring welded also a short length of bulkhead boundary bar to shell re-inforced with electric welding.
